PUBLIC HEALTH AND RELIEF (ORDINANCE) COMMITTEE MEETING PROCEEDINGS
May 14, 2024

The Public Health and Relief (Ordinance) Committee meeting was called to order by Chairman Meta Berg at 6:29 pm immediately following the adjournment of the Recreation Committee meeting. Roll call was taken. Members Present: Meta Berg, Shani Appleby and Cameron Looker. Also Present: Mayor Rich Luedke, City Administrator Marcus Rennie, City Clerk Rebecca Loehrke, City Treasurer Trina Herbst-Gutche, Police Chief Brandon Leschke, Chris Gunderson, Pat Gorchals, Austin Baehnman, Richard Rupno, and Carson Faulkner.

Motion Berg, second Appleby, to approve the minutes from March 12, 2024. Motion carried with all "ayes".

Citizen Appearances: None

Ordinance 2024-2 establishing Golf Cart Operation on Designated Public Ways: The submitted ordinance was reviewed by Attorney Kalny. He went over it and made some wording changes and deleted areas that were repetitive. Discussion was brought up on adding the time frame from April 1st to November 1st. Clerk Loehrke will make that change in the ordinance for Monday's Council Meeting. No trailers on Golf carts even during Trick or Treating. The Police Department will inform residents when they meet with them to get their permit. *Motion Berg, second Looker, to approve Ordinance 2024-2 establishing Golf Cart Operation on Designated Public Ways. Motion carried with all "ayes".* Can revisit the ordinance next year to see if any issues.

Discussion on establishing a Food Truck Ordinance: Rennie went over a proposed ordinance he submitted in the packet that is similar to Waupaca's ordinance. Discussion on how far the trucks should be from local establishments. The ordinance states 150 feet but can change to whatever the committee feels is appropriate. The Fire Department and Police Department will be required to do their reviews. Suggestion of the kayak launch parking lot as a good spot for a truck. Would be visible from a main road and plenty of parking. Some individuals feel that the food trucks take away from other local businesses. *Motion Berg, second Appleby, to forward the food truck ordinance on to the City Attorney for review.*

Discussion on creating a Festivals Ordinance: Rennie spoke on creating a Festivals Ordinance similar to Cedarburg. A board is created with the Administrator or a Council Member as a non-voting member to run festivals and celebrations in the City. Money that is left over after different festivals goes back to the City to be used. Rennie will work on getting more information and bring back for discussion.

Set next meeting date and time: The next committee meeting will be held Tuesday, June 11, 2024 immediately following the Recreation Committee Meeting.

Such Other Matters as Authorized by Law: Appleby asked Chief Leschke about ordinance violation enforcement. Officer Vue is taking care of the violations and currently is working on 12 properties.
