Discussion and Possible Action on Council Chambers Technology Repairs and Upgrade Estimate: The original quote from Arrow AV had an error so the updated quote has increased by over \$9,000. Schroeder met with a representative from Bluum Technologies to get another option. DuCoeur would also like to get one more quote from another company.

Discussion and possible action on Developer's Agreement with Sweetwood Builders: Schroeder received an email from Sweetwood that they are ready to start digging on lot one and would like the City to reconsider not extending the developer's agreement. They have also paid the fire protection up to date on the lots they own. They have not taken a building permit out yet. Much discussion from the committee on whether or not the agreement should be extended. *Motion Luedke, second Litscher, to allow Sweetwood 30 days to pull permit, start project and come to the next Finance Committee meeting to update. Motion carried with two "ayes" and one "nay". Motion carried.*

<u>Administrator's Report</u>: Schroeder reported that the 2023 Budget season is under way. He asked if the process he has followed in the past with timelines and requests still works. The City only had .73% of net new construction so there will be very little room in the budget. Schroeder will be sending out the timeline for the budget process soon.
